It was moved by Deputy Mayor Power, seconded by Councillor Hudson to approve the agenda as amended. Motion carried.

MOTION #C-2016-04-18-02

It was moved by Councillor Hudson, seconded by Deputy Mayor Power to approve the Council minutes from March 21, 2016 with the following amendments:

- Under Section 11, New Business, Item 1: Councillor Mersereau asked that the minutes be
 reworded to more accurately reflect his intended thoughts on the Library relocation, which
 were as follows: "Councillor Mersereau pointed out the Library identified they needed more
 space and there are two options to fulfill that need that were discussed. One: to add an addition
 to Town Hall. Two: to relocate to ARRA. Councillor Mersereau pointed out that both options
 would require capital investment."

Council all stated that they attended Chick Caldwell's funeral yesterday and that it was nice to see such a large crowd. Councillor Hudson stated that it was always past practice to have reserved seating for Council at a funeral and that this should be continued. Mayor Tompkins agreed that it looks good to have a formal way to have council represented. Mayor Tompkins requested that staff formulate a formal protocol for council attendance at funerals. Councillor Mersereau noted his reservations of this practice as he does not think that Council should take precedence over family and friends in attendance.

Mayor Tompkins and Councillor Mersereau attended the ARCAC arts auction. Both enjoyed the auction but noted some areas in which it could be improved.

i. Dog Park

CAO Barr updated Council on the proposed dog park. Discussion ensued.

MOTION #C-2016-04-18-03

It was moved by Councillor Mersereau, seconded by Deputy Mayor Power to approve the Active Living Coordinator's proposal for fundraising to raise funds for the dog park. Motion carried.

ii. Financial Condition Index

Councillor Mersereau pointed out that the way some of the information was presented and/or calculated in the Financial Condition Index Report by Municipal Affairs was incorrect. He stated that there are five reds listed but in actuality it is only three, as calculated by the Town. Discussion ensued.

11. NEW BUSINESS:

i. 2016/17 Budget Update

CAO updated Council on the budgeting process to date. Discussion ensued. A first draft will be presented at the Committee of the Whole meeting on May 4, 2016.

ii. ARRA Sign Permission

CAO Barr relayed that as part of the condo marketing campaign that signs on the ARRA building will be required. Currently the proposed signage requires a special motion from Council due to the Land Use Bylaw regulations for signs.

MOTION #C-2016-04-18-04

It was moved by Councillor Hudson, seconded by Councillor Mersereau to approve the allowance of signs at the Academy site for the proposed new condo development as per Section 7.5(i) of the *Land Use By-Law*. Motion carried.

iii. UNSM Conference

Council discussed whether or not to send CAO Barr to the USNM Conference. Council left it to CAO Barr to determine whether he thinks it is worthwhile to attend.

iv. Municipal Government Act (MGA)

CAO Barr asked if Council had any comments on the MGA Review. Council provided input.

v. Ad-hoc addition to the agenda: Discussion on iValley Presentation

Council discussed the presentation and directed staff to discuss with iValley about approaching the County and inquiring what their intentions are concerning FibreOP. Mayor Tompkins would like to see iValley have more communications with other stakeholders prior to proceeding further. Council would like to see a more detailed business plan and budget figures for the proposal.

It was moved by Councillor Hudson, seconded by Councillor Mersereau that the applicant at 209 St. George Street be given heritage approval to install a wooden deck and steel door as detailed in the application AR16-008-HER, providing the requirements of the Land Use By-Law are met. Motion carried.

Council expressed their concerns about a steel clad door- their preference is wood as wood is in keeping with the heritage aspect of town.
