i. AR16-005-HER – 200 St George St – Request to Alter a Heritage Property MOTION #PHAC 2016-04-04-03

It was moved by Councillor Paquette, seconded by Brian Bohaker to recommend to Council that the applicant at 200 St. George Street be given heritage approval to install a projecting wall sign and safety railing as detailed in the application AR16-005-HER, providing the requirements of the Land Use By-Law are met. Motion carried.

ii. AR16-006-HER – 304 St. George St – Request to Alter a Heritage Property MOTION #PHAC 2016-04-04-05

It was moved by Councillor Paquette, seconded by Councillor Hudson to recommend to Council that the applicant at 304 St. George Street be given heritage approval to install a window sign as detailed in the application AR16-006-HER, providing the requirements of the Land Use By-Law are met. iii. AR16-009-HER – 471 St George St – Request to Alter a Heritage Property MOTION #PHAC 2016-04-04-06

 iv. AR16-008-HER – 209 St George St – Request to Alter a Heritage Property (Tab 6) Theatre deck
MOTION #PHAC 2016-04-04-04 It was moved by Councillor Paquette, seconded by Brian Bohaker **to** recommend to Council that the applicant at 209 St George Street be given heritage approval to install a wooden deck and steel door as detailed in the application AR16-008-HER, providing the requirements of the Land Use By-Law are met. Motion carried. **Barry Moody declared a conflict of interest and abstained from voting.**

Councilor Paquette again summarized the proposed Heritage Plaque Program - have plaques at heritage homes that explain the heritage importance of the property and have a corresponding walking guide. The Committee discussed.
