a) AR15-002-DA – 209 St George Street

Planner Chris Millier reviewed the application for Development Agreement with King's Theatre, Annapolis Royal Wharf Association and the Town of Annapolis Royal. The application will consider the deck as an accessory structure as it is an extension of the lobby. The accessory structure is on three properties and two zones, one of the zones WF1 requires all development to be done by a development agreement. The application is consistent with all high level goals and criteria of the Town of Annapolis Royal. Chris Millier reviewed all relevant policies in the Municipal Planning Strategy and indicates the proposed development is consistent with all applicable portions of the policies relating to development within the WF1 zone

The application is extremely modest as no changes to the main house, driveway, or property are included in the application for this residential (R2) zone. Chris Millier reviewed the relevant policies in the Municipal Planning Strategy and indicates the proposed development is consistent with a majority of applicable portions of policies relating to development within the R2 Zone and consideration to the compatibility with adjacent land uses of the area and the impact on the heritage designation.
