5. BUSINESS ARISING

- i. Sector Review Residential
 - a) Heritage Property Act

Mayor Tompkins presented amendments that are going to be occurring to the Heritage Property Act and the insurance industry's reaction (the trend is for insurance companies not to insure heritage properties). The Committee discussed. It was decided that letters from particular groups such as realtors, the Annapolis Board of Trade, and the Annapolis Heritage Society will be sent to Minister Ince with copies to Premier McNeil and Mayor Tompkins. The letters will vocalize their concerns about insurance companies' unwillingness to insure heritage properties. CAO Barr will forward a copy of the original letter that was sent to groups that will be writing letters to the Minister.

b) Policies 6.2 to 6.20

The Committee and Chris Millier discussed sections 8 and 9 of the working document. Section 8, Residential Mixed Use (RMU) Zone, the third paragraph will be changed to "The Residential Mixed Use (RMU) Zone shall be applied to lands generally bounded St. James Street, Church Street, St. Anthony Street and Victoria Street and those bounded by Prince William, St. Anthony Street and Drury Lane.". Section 9, Business Uses in the Residential Designation (Policy 6.16): Chris Millier stated that The Land-

Use By-law should have definitions and criteria to regulate home offices. He asked that the Committee think about the percentage of properties that would be permitted to have commercial activity, the scope and scale i.e (where and how commercial uses could take place and the square footage). The Committee discussed whether renters should be permitted to operate a business in a property and permitted types of businesses. An explanatory paragraph that explains the rational for business uses and residential designation will be added in an introductory section of the working document. It was decided that Section 6.20 would be grouped with the discussion about 6.16-6.19. Chris Millier needs clarity on scope of home-based businesses. With regards artisanal, it is a subjective term. Need to consider whether to allow or restrict storage for commercial materials for construction contractors.

'Homework' for the next meeting: committee members are to give thought to what they want to see in/on properties beside them as business owners, residents, from different points of view. Chris Millier suggested that the definition of 'home occupation', in the LUB definitions found in the binder under Part 2, Section 2.33, be examined carefully and suggested edits made. Five areas are to be considered: commercial services, personal services, retail, industrial, and professional offices. Also give consideration to provisions in Section 8.3 (R1 Zone), Section 9.4 (R2 Zone), and 9.8 (R3 Zone). Chris Millier suggested that there be one overarching policy for all residential zones.
