# 9. DEPARTMENT REPORTS:

a) Chief's Report

Chief McNeil summarized the calls received by the Police Department for the month of August. The Board discussed.

Chief McNeil relayed that he spoke with Fred Stanford regarding the possibility of having a Department of Justice Operational Audit for the Annapolis Royal Police Department. Mr. Stanford's response was that the Department is too short staffed to conduct a review this year.

# 10. NEW BUSINESS:

a) By-law Enforcement of Town Policies

CAO Barr relayed that there will be upcoming discussions around by-law enforcement at next week's management meeting. Chief McNeil will be in attendance and the Police Department's role in by-law enforcement will be discussed at that point.

# b) Intersection Protocol

Deputy Mayor Power and Councillor Mersereau sought clarification for Council on Chief McNeil's opinion on having four stop signs at the lights at the intersection of Highways 1 & 8. The issue will be put on the next Traffic Flow Committee agenda.

c) Update from NSAPG<sup>3</sup> conference

Deputy Mayor Power and Chief McNeil summarized their attendance at the NSAPG conference.

d) Board of Police Commissioners Vacant Seat – Discussion

The Board discussed how to best approach filling the vacant seat.

# e) Email regarding "'Misappropriation of Town Funds"

Chief McNeil read the email that was submitted by Councillor Paquette regarding "misappropriation of town funds". Chief McNeil stressed that this is a serious charge and is actually a charge of criminal conduct. The email pertained to officers driving outside town limits when on duty, not criminal conduct. However, because of the use of the phrase "misappropriation of town funds", it has turned the complaint into a charge of criminal conduct and as such Chief McNeil has had to contact the Nova Scotia Police Commission Complaints

Office.

Chief McNeil and the Board discussed the concerns raised in the email. It was decided to address the concern in writing. The Chief will write his response and submit it to Chair Power. The Chair will then draft a response to the complainant. Chief McNeil agreed to limit officers driving out of town boundaries.
