#### APPROVAL OF REGULAR COUNCIL MINUTES:

The minutes of the June 18<sup>th</sup>, 2012 regular council meeting were discussed and the following corrections made:

3. Planning coordination services	CAO' St-Amour reported that at a meeting attended by herself and representatives of Middleton and Bridgetown, it was confirmed that beginning October 1 <sup>st</sup> the Town of Middleton will not provide planning services for any town other than their own. Also, the current building inspector will retire at the end of October, 2012, leaving another vacancy in the planning services area. St-Amour reported that the group is starting to look at how to proceed in an effort to service the Town of Annapolis Royal, Bridgetown and Middleton and that they will bring recommendations to Council as soon as possible.  Discussion ensued as to how much money is being paid by the Town to the Town Planner. He is currently paid \$1,670 per month as a retainer plus usage. It is noted that since his phone number is listed on the Town website, the public have been calling the Planner and he has been spending many hours in response to the public's numerous questions which is then billed to the Town.  It was decided that The Town Planner's phone number would be removed from the town website in an effort to control spending. The Mayor also suggested that the Planner's phone number be changed.

#### CORRESPONDENCE.

Council reviewed the correspondence.

- 1. Correspondence from Annapolis Royal Lions Club regarding power hook-up and pole. (Tab 4) Mayor Roberts asked who pays the bill for the power and Councillor Power asked if staff could look into this being a seasonal hook up, turned off in winter.
- 2. Notice of Public Hearing, NSURB<sup>9</sup> (Tab 5)
  Reassessment of tidal power plant is set for September 4<sup>th</sup>. CAO<sup>10</sup> St-Amour reported that accommodation has been booked for experts attending on behalf of the town.
- 3. Council reviewed correspondence from the Lifesaving Society.

#### OTHER BUSINESS

Councillor Fearon mentioned that she was surprised to find out from the Annapolis County Spectator that a new recreation person is being hired in Middleton. Discussion centered on the fact that programs coordinated by the new person will be available to the Town of Annapolis.

DFO Robinson told Council that the reports on the local radio station and in the local paper that the Town would not be receiving further equalization payments from the Federal Government were incorrect as the Town had in fact just received its payments for the 1<sup>st</sup> and 2<sup>nd</sup> quarters on July 13<sup>th</sup>.

Mayor Roberts encouraged all Councillors to attend the publicized Annapolis County ATV and Multiuse Trails Society meeting at Annapolis West Education Center this coming Wednesday evening at 7:00 p.m.

Mayor Roberts brought out a copy of the 2012 Nova Scotia Tourism map. He noted that the position of Annapolis Royal is shown in exceedingly tiny type and can hardly been seen. Also, the road which you can take from Hwy 8 through Baker's Settlement to Lunenburg is not even on the map. He noted that in his opinion the worst insult is the inset area which shows Annapolis Royal as a tiny little dot, with Digby being a little larger and Bridgetown very large indeed. He showed council the dotted line from Digby which extends out into the "water" and is captioned "approximately 3 hours" – no other note to say what is approximately 3 hours.

Mayor Roberts asked Council's permission to write to the publishers on behalf of Council expressing "our outrage and dismay". Approval was given.
