APPROVAL OF COMMITTEE OF THE WHOLE MINUTES

PRESENTATIONS

9:00 am: Mrs. MacDonald spoke on behalf of her husband, Stephen MacDonald. She thanked the Mayor and Council for their assistance in resolving issues surrounding an assessment appeal and outstanding taxes.

9:15 am: What is involved in applying for UNESCO² World Heritage Site Designation – Chrystal Fuller, ADPC³ Chrystal Fuller explained what is involved in pursuing UNESCO designation with a Powerpoint presentation. She stated that the benchmark for designation is "outstanding universal value", i.e. a value to society as a whole internationally. The documentation required is extensive and onerous.

The discussion revolved around the high costs involved, the geographic area that should be considered for designation, the partnerships that would be required, cost/benefit, and the Town's current financial situation.

9:40am Dave Shelton from the Office of the Fire Marshall in Annapolis, Maryland presented the Mayor with a picture of Annapolis, Maryland showing the Nova Scotia flags flying over the streets of Annapolis, Maryland. In honour of the 300th Anniversary of the naming of Annapolis Royal, the Nova Scotia flags are once again flying over Annapolis, Maryland. The picture is being presented by Mayor Josh Cohen. He also poduced a certificate and flag from the State Governor that will be presented to the Lieutenant Governor when she is here on October 10 for the 300th anniversary of the first Anglican service in Canada.

9:45 am: Dr. Bob Mahar Brought two presentations with him. He runs the Applied Geomatics Research Group (AGRG) at COGS⁴ and has been doing so for 10 years. There are 30 staff. They have been using technology to solve a number of problems, mostly environmental. Everything they do involves work with the private sector and communities. They do community economic development. They apply for funding for research activities which require involvement of all three levels of government, communities and the private sector. Increasingly, there is a requirement to be seen to be and to be more collaborative.

Community Mapping: If we are going to talk collaboration, everyone needs to have the same information. AGRG continues to do a lot of work on climate change and sea level rise with detailed mapping. Recently, community mapping work has involved moving the technology out of the world of the research community into the world of the public. Google is increasingly popular. People can now produce their own map products using the technology available. Citizens are updating and keeping maps more current than government organizations can. Traditional topographic maps are now considered base maps. Aerial photographs are also used to produce base maps. However, information to do with arts and crafts don't come from the provincial government – that information has to be assembled by the people who know the information before it can be shared with others. Saltscape Magazine talks about apps being delivered through your telephone and other hand held devices – location of restaurants, etc.

Project 1: Inverness County \$70,000 Sustainability Planning

This is an example of what other perhaps more progressive communities are doing. The County of Inverness, like every other jurisdiction in Nova Scotia, had to complete an ICSP⁵. Inverness County went one step beyond that. They decided to map their assets. They received funding to do that. They did the data collection and AGRG developed the solution for them. They hired three people for a year to collect data.

Project 2: Rural Secretariat Project, Annapolis and Digby County \$400,000-\$500,000

The funding for this project is over two years and it hasn't started yet. The project involves developing a footprint for Annapolis and Digby Counties that can be later extended out to all of South West Nova. Dr. Maher stated that he originally approached

ADEDA to see if they wished to support this project. They declined but Annapolis County, DSWNS⁶ and the 300th Anniversary and others are supporting the project. This project is using the same technology for Project 1.

Project 3: ACOA⁷/ICF Project \$1.3 million: Community Information Utility

This project is sitting with Team South West Nova Scotia. This project involves organizing data regardless of all the little geographies to create a data warehouse for the benefit of everybody. This would require all parties to share their data. It also involves the challenge of securing funding. Dr. Maher said that governance needs to be addressed up front. Unless people are willing to share data, there is no point in pursuing the project.

Dr. Maher states that he will continue to support what we have been doing on the 300th and the CLICK Project. He needs a letter of support from the Town which may include cash or in-kind support. Second, he needs the Town to understand the projects.

Staff will be asked to recommend whether or not the Town can and should make a financial contribution. The CAO will circulate copies of the two presentations to members of Council.
