#### 4. PRESENTATIONS:

## i. Annapolis Valley Chamber of Commerce – Judy Rafuse

Judy Rafuse, Executive Director, Heather Leeman, and Loretta Kalkman briefly updated the Committee on the background of the Annapolis Valley Chamber of Commerce. The membership is currently from the Avon Valley to Digby with approximately 80-100 members. AVCC has requesting funding from the Province, and all the Town and Municipalities in the area. AVCC is requesting \$10,000 for a marketing strategy to promote the Annapolis Valley as a whole. The strategy is based on the Banff and Newfoundland marketing plans. The request for funding is based on a four year plan, hoping to be self-efficient in the third and four years.

#### ii. Southwest Nova Biosphere Reserve Association – Cliff Drysdale

Cliff Drysdale, Chairman of Southwest Nova Biosphere Reserve Association, described the history of SNBRA. In 2001 the United Nations Educational, Scientific and Cultural Organization (UNESCO) as a "site of excellence where new and optimal practices to manage nature and human activities are demonstrated. SNBRA is requesting \$300 to complete the smart phone/tablet/website "Map App" visitation planning / heritage information tool, and production of complementary brochure and branding materials. Mr Drysdale showed the Committee how the current website is working and how phase 2 would be integrated.
