7. PUBLIC INPUT:

Byron Mersereau requested information on when Council receives the financial information as it is not on the agenda today. 10. BUSINESS ARISING:

i. Commercial Property Assessment Increase By-Law – Report for Decision

CAO Barr updated Council on the direction of the revised By-Law. The two significant changes in the Annapolis Royal version includes a minimum threshold before someone can apply for the rebate and also outlines how the rebate could arise due to the sale of the property rather than solely development. All the changes have been made and will be circulating back to the province for review.
