11. NEW BUSINESS:

i. Hillsdale House Inn Noise By-Law Exemption

CAO Barr outlined the request received from the Hillsdale House Inn for a Noise By-Law exemption for two of the six weddings that they have booked for this summer, July 15, 2017 and July 22, 2017. They are also requesting for the fee to be waived as part of the towns promotion of Annapolis Royal as a wedding destination. Council discussed the options on the exemption of the fee and decided that the fee would not be waived.

It was moved by Councillor Kinsella, seconded by Councillor Sanford that Jerri Costa and Wayne Morgan be declared honoree citizens of Annapolis Royal. **Motion Carried.**

iv. REMO – Joint Council Meeting and Municipal Evaluation Results

CAO Barr reviewed the information on having a joint REMO meeting and the evaluation results that have been received. The joint meeting would include all three Councils and the Province to discuss the leadership role and a plan on moving forward. Council discussed how productive the meeting would be to have all Councils in attendance. An information session would be helpful for all members to review the results and the responsibilities of each group. CAO Barr will communicate with the other CAOs and set up a meeting.

v. Payphones

CAO Barr updated Council on receiving letters from Bell on the removal of two payphones, one at Town Hall and one located across from Charlie's Place due to declining usage. There is a payphone located at King's Theatre and staff will contact Bell to make sure this location is not being removed. Council would

like to keep the payphone located at Town Hall as a public safety issue and request that Bell waive the monthly fee.

MOTION #C2017-MAY-15-06

It was moved by Councillor Sanford, seconded by Councillor Elliot to approve to retain the one public pay phone in front of the Town Hall at the cost of up to \$50 per month. **Motion Carried.**

vi. UNSM Correspondence

Mayor MacDonald reached out to the Annapolis Board of Trade to organize a candidate meet and greet at our community level due to the correspondence received from UNSM. The Annapolis Board of Trade has agreed to sponsor the event in name only. Mayor MacDonald sees the value in organizing the event and having an outside party MC. Council is concerned with the short timeline but will proceed to invite the three candidates.

It was moved by Councillor Elliot, seconded by Councillor Kinsella to direct staff to attempt to organize an all candidates meeting in conjunction with ABOT prior to the Provincial Election, subject to candidates' availability. **Motion Carried.** 1 Nay Vote Deputy Mayor Power.

It was moved by Councillor Sanford, seconded by Councillor Elliot that Council approve to accept the 50% contribution under the Provincial Capital Assistance Program, up to a maximum of \$150,000, for the rehabilitation of the Lequille Water Reservoir as outlined in the recommendation from Hatch dated July 12, 2016 and to proceed with the project based on the updated estimated total cost of \$401,919. **Motion Carried.**

It was moved by Councillor Elliot seconded by Deputy Mayor Power that Council approve to direct Noah Scanlan to dispose of the outdoor adult gym equipment either by selling or donating it to a group with the condition that a contract outlining the safety concerns of the equipment be included, or sell for scrap metal. **Motion Carried.**

MOTION #C2017-MAY-15-12

It was moved by Deputy Mayor Power seconded by Councillor Kinsella that Council approve a maximum of \$15K previously allocated to ARCAC to be used for the completion of the Tancook Whaler with the intention that the boat to be sold and the proceeds used to fund a second boat. **Motion Carried.** 1 Nay Vote Councillor Elliot

MOTION #C2017-MAY-15-13

It was moved by Councillor Elliot to amend the motion to exclude" and the proceeds used to fund a second boat". **Motion falls to the floor, as no one seconded the motion.**

MOTION #C2017-MAY-15-14

It was moved by Councillor Kinsella, seconded by Councillor Sanford that Council encourage the Historic Gardens to have a donations only admission day on Canada Day and the Town will top up the difference to the maximum of \$2000 from the Communities, Culture and Heritage grant. **Motion Carried.**

It was moved by Councillor Sanford, seconded by Councillor Elliot that Council approve to establish the Investment Committee. **Motion Carried.**

MOTION #C2017-MAY-15-16

It was moved by Councillor Elliot, seconded by Deputy Mayor Power that Council approve that the Town offer space at the King's Theatre plaza for the Friends of the Library to hold a book sale twice a month for June, July and August and the Town waive the Vender application fee. **Motion Carried.**

MOTION #C2017-MAY-15-17

It was moved by Deputy Mayor Power, seconded by Councillor Kinsella that Council approve the disbursement of funds for surveying of all Town boundaries to a maximum of \$2000. **Motion Carried.**

It was moved by Councillor Kinsella, seconded by Councillor Sanford that Council gives the applicant at 209 St George Street heritage approval to install steel doors, as a non-conforming use and this no way to set a precedent for application AR17-007-HER, providing the requirements of the Land Use By-Law are met. **Motion Carried.**

It was moved by Councillor Sanford seconded by Councillor Elliot that Council gives the applicant at 519 St George Street heritage approval to replace the current ground sign with the new design, as detailed in the application AR17-011-HER, providing the requirements of the Land Use By-Law are met. **Motion Carried.**
