AR17-007-HER – 209 St George St –Request to Alter a Heritage Property

CDC Millett-Campbell updated the Committee on the other options available to make the steel doors have a more heritage feel. The applicant showed the Committee a sample of the painting technique that is available to make the doors have a wooden look and the research on the durability of the veneer sample that was presented last month. The Committee discussed the options and the applicant answered the Committees questions.

It was moved by Peter Davis, seconded by Carol Hanson that PHAC recommends to Council that the applicant at 209 St George Street be given heritage approval to apply a painted wooden grain technique in a lighter colour and using a straighter grain with less knots than shown in the sample for application AR17-007-HER. **Motion Defeated.** Councillor Kinsella, Councillor Sanford, Mayor MacDonald, and Chair Barry Moody voted Nay.

It was moved by Councillor Sanford, seconded by Councillor Kinsella that PHAC recommends to Council that the applicant at 209 St George Street be given heritage approval to install steel doors, as a non-conforming use and no way to set a precedent for application AR17-007-HER, providing the requirements of the Land Use By-Law are met. **Motion Carried.**

ii. AR17-011-HER – 519 St George St – Request to Alter a Heritage Property

CDC Millett-Campbell summarized the application to replace the current sign to a new updated version.

The land in question is owned by Department of Transportation so if they department wishes they can exercise their right as a provincial land owner and not abide by municipal regulations. If a Development Agreement is required the Committee may be asked to hold an emergency meeting to help facilitate the timelines for the project to stay on schedule.
