The Committee discussed the opening text and the policies that follow in Part 13. Planner Millier will update 13.1 and 13.2 to use consistent language as throughout the policy; change 13.3 to read "existing residential units" and include in 13.3 b) "licenced premises" after restaurants; under 13.4 include "on the Historic Garden Society site". The Committee would like also add a new 13.4 lands purchased by the Society to be used by the Gardens addition may be rezoned to HG without requiring an amendment to the Municipal Planning Strategy.

The Committee would also like to add a new Part 14 for Fort Anne. The Committee would like to remove further restoration to on-going restoration and add interpretive activity under the permitted uses.

The Committee discussed the importance of Museums to our Town and decided that it should have a sub-section on its own. Mayor MacDonald and Chair Nicholson will prepare the opening text for the next meeting. The Committee discussed how museums should be zoned or if they should be allowed in all zones, the permitted uses and potential for new museums and regulations around them.
