a.) Update from Council

### b.) Police vehicle

Chief Moser informed the Board that the new vehicle would arrive by the end of September or early October. The new vehicle would still require the installation of police equipment prior to being functional for the department. He reported on the repairs and maintenance of the current police cars. Adding that he was able to obtain free engine repair for the Dodge by negotiating with Dodge Canada. It was agreed that a letter of appreciation should be sent from the Board of Police Commissioners to the Kentville Board of Police Commissioners for the loan of one of their police vehicles. Chief Moser will draft a letter for the Board.

c.) Change in criminal record check fees

The Board reviewed the proposed changes to the criminal record check fees. Chief Moser explained that it is a generally accepted practice that people pay a minimum of \$25.00 for record checks. He added that it is also rare for a department to provide record checks for residents from outside their jurisdiction. He explained that the proposed fees, \$10.00 for residents and \$25.00 was reasonable. He stated that the fee may be waived by the discretion of the Chief if the check was required for volunteer work. The Board discussed the matter. It was agreed that the effective date would reflect council approval.
