Under 4.27 Chair Nicholson will rewrite into three sections to have the residential yard sales and list the regulations clearly with an opening sentence outlining the community standard with the Valley Waste regulations and standards, then list the regulations for the Community Organizations Sales and Flea Markets with the same Community standards as Valley Waste and remove the requirement of obtaining a development permit. Under 4.28 remove the reference to the mobile home or mini home structures as the Committee has removed the zone. Chair Nicholson will update and include the temporary uses subject to section 4.11. Under 4.30 Chair Nicholson will update this section.
