i. Review of Working Document

Chair Nicholson and the Committee reviewed the section on Yard Sales. Under 4.27.1 and 4.27.2 the Committee decided to add "in any calendar year" and in 4.27.1 last sentence add "or second hand goods acquired for resale."

# 7. NEW BUSINESS:

i. Part 2- Definitions

The Committee reviewed the definitions and made the following changes.

Remove Air B n B and include in the title of Short Term Rentals.

Under Amenity Space add "may include private or common landscaped areas" and remove private amenity area.

Under Building remove "or vehicle".

The Committee discussed the addition of the Change of Use definition and the need for further conversation on the zoning changes and the non-conforming lots. The Committee needs to review the process for a zone by zone review.

Under Commercial Schools replace "secretarial school" with "business school" and add Informational Technology to the list and include ..." may include but not limited to..."

Under Commercial Motor Vehicles add "...includes but not limited to..." and clarify trucks greater than 1 ton.

Under Community Centres add "...or designated agent."

Under Converted Dwelling change "three" with "two or more dwelling units."

Under Corner Vision Triangle include the diagram under the definition.

Under Development remove the highlighted "on the land."

Under Double Duplex add "Fourplex" for clarification.

Under Dry Cleaning or Laundry Establishment add at the end of the sentence "but does not include laundromats."

Under Dwellings the Committee would like to list all the groups and definitions together so everything is together.

Under Dwelling Unit include "Apartment"

Under Established Grade Levels remove "in reference to" in a), b) and c).

Under Floor Area add "in reference to" then copy same format as in Established Grade Levels.

Under Home Occupation add "shall include but not limited to" and remove ..." without limiting the generality of the foregoing".

Under Hotel remove "members of"

Create an Accommodations section and list all the definitions similar to the Dwellings Section. Add Intuitional Use to the definition list.

Add a new section for Lots and list all the definitions similar to the Dwellings Section.

#### ii. Extension of Ritchie Street

Deputy Mayor Power requested clarification on the intent of extending the road from Ritchie Street to Victoria Street. The Committee discussed to options of removing the road provisions or leaving the document in place for further consideration.
