11. NEW BUSINESS:

i. Fire Hall – Discussion

Interim CAO Robinson summarized the request from the Fire Department to pay for an invoice for snow plowing by a private contractor for Chase the Ace. She iterated that the Town will not pay for this as Publics Works attempted multiple times to plow that day and we do not bring Public Works in after hours to plow for special events. Discussion ensued. Council directed staff to write a letter to the Fire Department clarifying the issue and to reiterate that the Town will not be paying the invoice.

ii. Library – Discussion

Council discussed several items pertaining to the Library:

- A donation was given with the expectation that electrical outlets were installed in a specific area
 of the Library for SOFAAR's equipment. This was not done. The donor wants this rectified.
 Mayor MacDonald will investigate if there are funds to remedy the situation. Interim CAO
