## 2. Business Arising

i) Questions regarding the draft MPS / LUB document

MEAC Chair Jane Nicholson updated the members of PHAC and Council on the work that MEAC has done to date on the draft MPS and LUB documents. Ms Nicholson and Planner Miller reviewed the answers to the questions submitted by the PHAC members.

The Committee discussed the zoning maps and why all the Town's facilities are not listed on the maps. The Committee discussed how the draft documents include the facilities as an allowable use in the zones and have not spot-zoned facilities: such as the skateboard park, dog park, French basin trail and the parking lot leading to the trail head. PHAC members agreed they would like to have a new stand-alone policy to include the Parks and Open Spaces facilities. Planner Miller will prepare the text and update the maps to include this change.

The Committee discussed short term rental and the need to be owner occupied in the residential zone. The Committee agreed that a definition for ordinary resident and/or owner-occupied needs clarification. Would this include or be limited to six months plus one day or defined by the calendar. The Committee agreed to leave the draft as presented with owner occupied in the residential zone.

The Committee discussed the 6.3.2 in the MPS, the definition of multi-purpose corridors and clarification that all-terrain vehicles are still not permitted on the trail system.

The Committee received clarification on 14.6.6 in the MPS, on dockless vehicles.

The Committee discuss the LUB definition of #39 Kennel. The Committee would like to the word "livestock" be removed from the definition and clarify what animals would not be allowed, such as pot-bellied pig, miniature horses, etc.

The Committee would like a definition added to the LUB for a stockade fence. As 4.14.4 (a)stockade-style fences shall not be permitted.

Planner Millier will make the recommended changes to the draft MPS and LUB documents and update the maps to include the Parks and Open Spaces Facilities. The updated draft MPS and LUB will be on the July 2<sup>nd</sup> agenda for recommendation to Council for 1<sup>st</sup> Reading. Council will at that time pick a date for the public hearing, probably at the September Council meeting.

Chair Moody thanked Planner Miller and MEAC Chair Nicholson for all the hard work to date on the documents.
