8. PRESENTATION: Constable Jonathan Theriault – By-Law Review

Constable Theriault overviewed the current Town of Annapolis Royal By-Law.

Format should be consistent for all by-laws. The goal is to have all by-laws look the same and have a good flow for better understanding. Also, it was recommended to create a Public Places by-law that have an enforcement component, the way to enforce a by-law, and scheduling a by-law (pros and cons). Recommendations were provided for Dog By-Law, specifically for Dog Annual Registration.

Action: Council to revisit the current by-laws with CAO Millett-Campbell based on the provided recommendations.

9. BUSINESS ARISING:

Trails Closure

Mayor MacDonald updated on his recent call with Minister of Justice regarding the trails closure. He is waiting for a letter from the Minister with clarification on the closure of trails in the Parks and Open Spaces Zone through the Land Use By-Law. Council re-visited the closure of the Boardwalk and trails and whether the decision should be amended. Council had further discussion on the option to amend the current motion for the closure.

MOTION #C2020-04-20-08:

It was moved by Councillor Hafting, seconded by Councillor Kinsella that Council open Harvest Moon trail, French Basin trail, the Pierre DuGua Promenade in compliance with the current Nova Scotia state of emergency dynamic. **Motion Defeated** (3 Nays: Mayor MacDonald, Deputy Mayor Power, Councillor Sanford)

ii. Bus Shelters

Mayor MacDonald will bring this matter to the Budget meeting for further discussion and action.

iii. Town Hall Space

Council discussed the Town Hall space and the proposed layout to move Council Chambers downstairs for better public accessibility. Mayor MacDonald will bring this topic to the Budget meeting. \$10,000 funds were allocated for the proposed renovation.

iv. Council Remuneration

This matter will be added to the Budget meeting for further discussion and action.

v. King's Theatre Sprinkler System Funding Request

CAO Millett-Campbell confirmed that the Insurance policy is now in place and updated Council on the amount of time that the Director of Finance has done to accommodate the ask from Council. CAO Millett-Campbell reviewed the current lease with King's Theatre that outlines they are responsible for the repairs and maintenance for the sprinkler system. The CAO asked for directions regarding the King's Theatre Sprinkler System and the request received to support for the additional funding.

MOTION #C2020-04-20-09:

It was moved by Councillor Sanford, seconded by Deputy Mayor Power that Council approve to pay King's Theatre \$3875,76 (50%) to be used towards repair of the Sprinkler System. **Motion Carried**
