#### 9. NEW BUSINESS:

i. New Police Chief

CAO Millett-Campbell informed the Board that the new Chief position was offered and accepted. The incumbent and his family are on their way to Nova Scotia and will start working on November 16, 2020 while in two weeks of quarantine. The Swearing-In Ceremony will take place on November 30, 2020 (time TBD) with a small official ceremony considering public health guidelines. Chief Moser will be working with him until his last official day on December 5, 2020.

# **10. BUSINESS ARISING:**

i. Update from Council

Deputy Mayor Power reported that at the Council meeting on October 19, 2020 they approved the two recommended motions from the last meeting and discussed the upgrades to the security system and the new police chief. At Committee of the Whole, Councillor Hafting along with Deputy Mayor Power were appointed to be Council representatives on the Board. CAO Millett-Campbell informed the Board that upgrades on the security system have started and IT

work is being completed in the Police Department.

## ii. By-Law Approval

## iii. Extension for Corporal Cleaves

Chief Moser explained that it would be appropriate to make another extension for Corporal Cleaves as there will need to be a transitional period for the new police chief to get adjusted. The Board agreed.
