

# ANNAPOLIS ROYAL POLICE SERVICE Auxiliary Officer Program

#### **BASIC REQUIREMENTS**

- 1. Canadian Citizen or permanent resident of Canada.
- 2. At least 19 years of age.
- 3. <u>Grade 12 education</u> or equivalent.
- 4. Must possess a valid first aid and CPR certificate (or once engaged in role within 6 months of hire)
- 5. Must possess a valid driver's license (unrestricted).
- 6. Provide Resume and Cover Letter
- 7. Must be capable of passing a complete medical and physical examination, if required.
- 8. **NO CRIMINAL RECORDS**. No convictions of any offence under the Criminal Code, for which you have not received pardon. Have no charges pending before the Courts.
- 9. <u>Good character</u> and habits background will be checked. (Criminal Record/Vulnerable Sector Check and Child Abuse Registry Check)
- 10. Provide 3 Professional Letters of Reference.
- 11. Preference will be given to applicants that reside within 30 Kilometers of the Town of Annapolis Royal.
- 12. Please include the following as one package,
  - a. Auxiliary Constable Application Form (This form)
  - b. Resume of Cover letter
  - c. 3 Professional Letters of Reference
  - d. Criminal Record Check
  - e. Copy of Driver's License
  - f. And, one other form of Government ID (Health card, Firearms license...)
