9. **NEW BUSINESS:**

i. Budget

Chief Kane went over the 2021-22 police services budget as it was previously evaluated by himself and the Director of Finance, Melony Robinson. It was noted that stat pay has increased, while stand by pay decreased since Chief Kane will be instituting a new schedule with 10-hour shifts. Other items that were discussed were IT services, fine revenues, and training costs. The Board agreed to accept the budget as presented.

ii. Criminal Record Checks

Chief Kane stated that the current fee for a Town resident to get a criminal record check is \$25 which he then asked the Board to increase the charge to \$30. It was explained that criminal record checks take a lot of work and staff time, and \$30 is a standard price at other departments. Chief Kane reminded the Board that they only charge for a criminal record check if it is for employment purposes, while one for volunteering is free. The Board agreed to increase the fee from \$25 to \$30 and asked that the information be shared with the public via Town Crier and website.
