9. **NEW BUSINESS:**

i. Police Cadets

Chief Kane informed the Board that the Department had two new police cadets from the Police Academy start at the beginning of the week that will working with them for the summer. Both cadets live locally and are settling in well. It was noted that the Academy provides their students with uniforms and liability insurance. The Board agreed that they will be a great addition to the team.

ii. Police Complaints

Chief Kane stated that members of the Board and Council have to be cautious when dealing with police complaints as it gets complicated within the legislation. It was explained that individuals should direct complaints straight to the Police Chief as the process can be difficult if not handled the proper way. The Board briefly discussed the matter and agreed with Chief Kane.

10. BUSINESS ARISING

i. Update from Council

Mayor Boyer reported that Council has finished the strategic plan that will be approved at the June Council meeting and are now focusing on the climate change plan. Mayor Boyer explained that she and CAO Millett-Campbell have applied for over half a million dollars in climate change funding. It was noted that if the Town receives a particular grant, then some of the funds can be
