## 9. **NEW/UNFINISHED BUSINESS:**

i. State of Emergency Update

CAO Millett-Campbell noted that the new Proof of Vaccination (PoV) plan is in effect. There are no longer distance/gathering limits for events at recognized businesses, but the limits for informal gatherings remain. The PoV is required for "non-essential" events. Today in Nova Scotia there are 231 active cases, with 26 in the Western Zone, 23 in hospital, and 4 in ICU.

ii. Request for Decision – Human Resources Policy Update
 It was proposed to add the new Truth and Reconciliation holiday to the HR Policy Manual

## MOTION #CoW2021-10-04-03

...to recommend to Council the addition of the new holiday (The National Truth & Reconciliation Day) to the Human Resource Policy. Regularly moved and seconded. **Motion carried.** 

iii. Request for Decision – Meeting Dates Change
It was proposed to change the meetings dates for Committee of the Whole and Council to the first and third Wednesday of the month to facilitate the new staffing schedule

...to recommend to Council that as of November 1, 2021, Committee of the Whole meetings will be held on the first Wednesday of the month and Council meetings will be held on the third Wednesday of the month. Regularly moved and seconded. **Motion carried.** 

iv. Request for Decision – Rescind Policy for Computer Purchases
 It was proposed that the HR Policy Manual be updated to remove the policy on computer purchases. It was noted that the policy has not been used in years and has had relatively little

uptake. Council discussed the merits of leaving it in place "just in case" versus removing it and streamlining the manual.

vi. Request for Decision (RFD) – Beyond Oqwa'titek 2022
CDC Knox shared with Council that as part of the Terms and Conditions for funding for Beyond
Oqwa'titek 2021, a final report must be submitted. For recurring events such as Beyond
Oqwa'titek, a provisional budget for the next event must be included. The RfD asks Council to
approve the provisional budget.

...to recommend to Council that the Town approve a draft budget in the amount of \$30,000.00 for the 2022 Beyond Oqwa'titek celebration provided that all due diligence is completed to support this budget and that all cash funding for the celebration be from external sources. Regularly moved and seconded. **Motion carried.** 

vii. Annapolis REMO Advisory Committee Recommendations
Mayor Boyer and CAO Millett-Campbell updated Council on the status of REMO discussions with
Annapolis County and Middleton. The draft By-Law was also discussed.

...that pursuant to the recommendation of the Regional Emergency Management Advisory Committee, that Council give first reading to approve the C6 Regional Emergency Management Agreement as amended and without schedule C. Regularly moved and seconded. **Motion carried.**

## viii. Saltwire Request for Community Content

Mayor Boyer shared a request from Saltwire network asking for regular updates of Council activity for publication. Council discussed the issue and felt this could be a positive means to increase our reach and engagement. Mayor Boyer agreed to provide a factual accounting of Council activities/decisions.

### ix. Police Car Purchase

Chief Kane submitted to Council a request to purchase new police vehicle. The Town has been offered a demonstration vehicle with low (3000km) mileage at a savings. If replaced, this would be one year ahead of schedule. The offer is good for 30 days. Council discussed the potential savings as well as the status and maintenance costs for the vehicle to be replaced. Council Hafting has requested the current mileage of the vehicle to be replaced and its maintenance costs as soon as possible.
