- II. Climate Ambition Campaign, David Suzuki Foundation
  - a. Mayor Boyer noted that she signed the petition on her own personal behalf and was sharing this information with the Committee to ask about whether the Committee would be interested in getting involved in such campaigns. It was suggested that if the campaigns are about issues relevant to the community that they can be brought to the Committee which can then decide whether to show support individually or collectively or both.
- III. Clean Leadership summer internship (Clean Foundation) program grant

a. CAO Millett-Campbell and Mayor Boyer worked on the grant together and it was submitted. If approved, it would provide for a summer intern for 15 weeks with a 60/40 wage split, 40% being the Town's share.

Chair Bottomley has been working on a flood risk assessment that can be used to feed into the next step for the climate change plan process, an engineering report.
