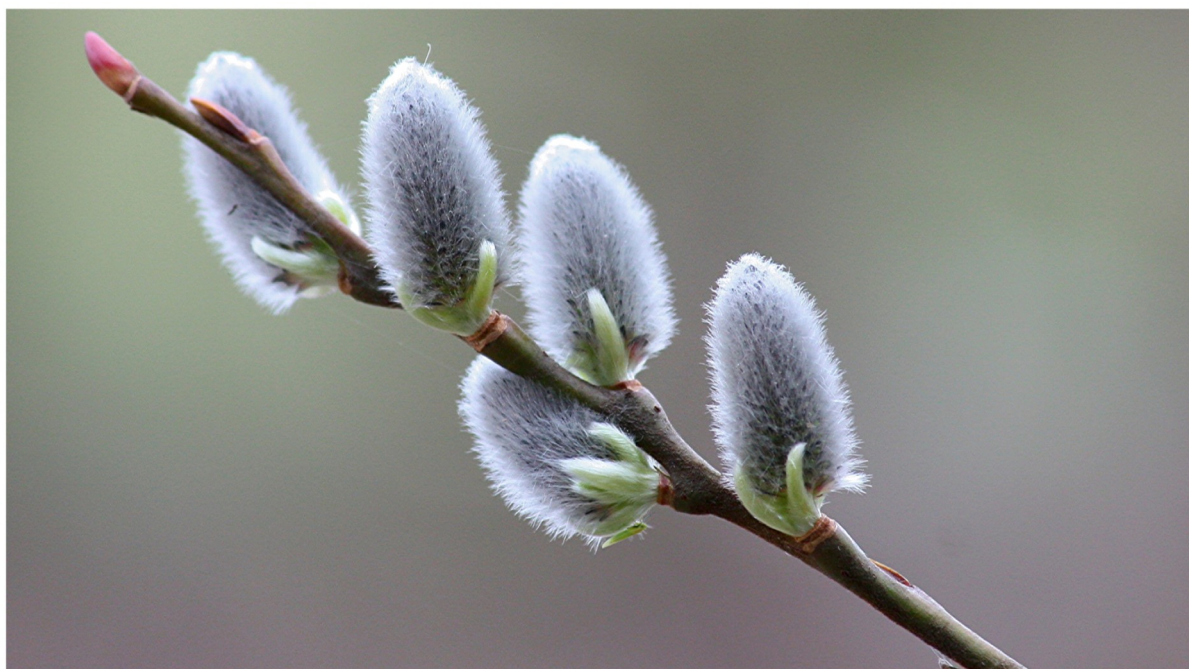

The Annual Budget Process

It's that time of year again, and the Town has begun the budget process. It all starts with the staff of the Town consolidating everyone's needs and wish lists into one "kitchen sink" budget that balances, meaning revenues = expenditures. Then, a public meeting is set to go over this first snapshot and begin preliminary discussions. The first public meeting on the 2022-2023 budget was held on February 9, at 5:00 pm and the preliminary draft budget was made available on the Town website.

As Council deliberated the first draft, the Director of Finance began making changes that will result in a second draft budget. So, by the time we get to the second public budget meeting on March 1, 2022 at 5:00 pm, there will be a second draft available for viewing on the Town website.

There are some numbers that we can immediately confirm for the coming fiscal year. This includes confirmed sources of revenues such as provincial money from Equalization (\$91,156), the Police Boots on the Street program (\$100,000), and forecasts provided by Town Department Heads such as Triton revenues for criminal checks conducted by the Police Department. There are also fixed expenses that we can confirm and forecast expenses such as expenses related to Valley Waste, the Annapolis Valley Regional Library (AVRL), and so on.

Some expenses the Town has no control over. These include expenses related to the Housing Authority (\$30,000), Correctional Services (\$11,249), and the Annapolis Valley Regional Schoolboard (\$147,109), for example. Other expenses, such as those related to the Annapolis Royal Library, are partly mandatory and partly discretionary. Total costs for the Hub, which includes the Library and the gym, costs approximately \$27,7230 about the same as the costs for the Comfort Centre (\$26,183).

Some costs are offset by revenues such as grant and contributions from other sources. For example, although revenues for Recreation were forecast to come in at \$44,500 this year, additional grant money mostly related to addressing accessibility requirements means that we are forecast to end the year with revenues of approximately \$77,979.00.

The Town produces four (4) annual budgets: Town Operating, Town Capital, Water Utility Operating and Water Utility Capital. In addition, the Town has a Capital Improvement Fund that forecasts all Town vehicle and major equipment requirements over multiple years so that we don't wait until something has passed its useful life to order a replacement.

Although a lot of work goes into budget preparation, there are many opportunities along the way for you to be kept informed and to ask questions. When it comes to financial matters, there is no such thing as a stupid question. If you are looking at the different versions of the Town draft budget for the first time, you can start by picking out things that look familiar to you like power and phone bills and start circling anything that is not clear or that you do not understand. Make a list of any questions that you may have and start asking questions. It is anticipated that there will be many versions of the budget as we work our way through it. We are no way near the final budget yet.



Powering Innovation

In March of 2020, through a partnership with Clean Annapolis River Project, the town of Annapolis Royal installed a photovoltaic system on the roof of the Annapolis Academy. By October of 2020, the system was fully connected, and it has been producing power for the Town ever since.



The system serves another purpose; to provide a demonstration of what a household-scale solar panel array can produce annually in order to help homeowners who are interested in solar energy decide and plan their path forward. As such, the system was scaled to generate 12,000kWh/year; a little more than the 10,000kWh used by the average NS household.

We are happy to report, based on the first full year of generation by the system in 2021, that it has slightly outperformed our expectations by generating 13,130kWh between January 1st and December 31st of that year.

Avian Influenza in Nova Scotia

In late January a case of Avian Influenza was confirmed in a Canada goose. Since then additional cases have been confirmed in the wild and in two poultry farms.

"Avian influenza poses little risk to people, but the virus is highly infectious and potentially deadly in wild and domestic birds. We urge the public to avoid feeding or handling wild birds like ducks, geese, pheasants, pigeons, and gulls to prevent disease spread." 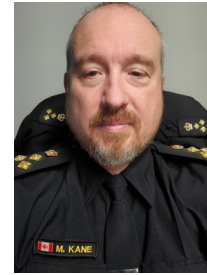

As it is Fraud Prevention month Annapolis Royal Police has partnered with the Canada Revenue Agency to provide valuable information to prevent fraud.

Fraud Prevention Month: Be Scam Smart this Fraud Prevention Month

Every year, Canadians lose money to fraud. Last year alone, Canadians lost over \$275 million compared to \$106.6 million lost in 2020 (Canadian Anti-Fraud Centre). You may receive a phone call from someone claiming to be from the Canada Revenue Agency, but is it really them? Here is how you can tell the difference.

The CRA may contact you to:

- ask about a tax debt
- start an audit process
- offer free tax help for your small business
- offer support in helping your clients access benefits and credits



The CRA will not:

- demand payments by Interac e-transfer, bitcoin, prepaid credit cards or gift cards from retailers such as iTunes, Amazon, or others
- use aggressive language or threaten you with arrest or sending the police
- leave voicemails that are threatening or give personal or financial information
- ask for a fee to speak with a contact centre agent

If you're unsure if the call you're getting is legitimate, hang up and contact the **CRA at 1-800-959-8281**.

But keep in mind, scams are not always done through phone calls. You may come across them in text messages, emails, and mailed letters.

Protect your personal and financial information by taking a moment to ask yourself if the caller or message is legitimate, before sharing anything.

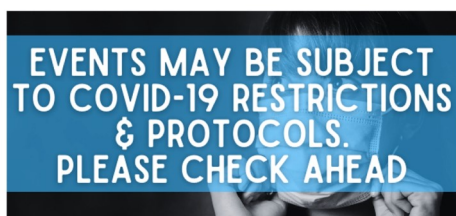

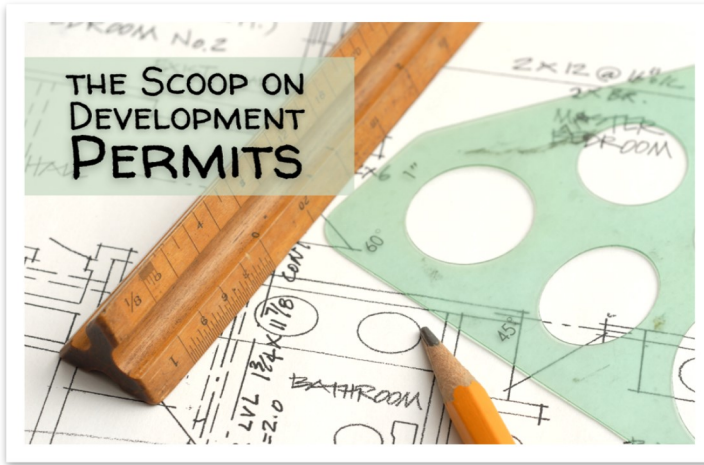

What is a Development Permit and Why Do I Need One?

By definition a Development Permit is “a municipal permit issued by the Town’s Development Officer following the submission of a completed application which confirms, in accordance with all relevant provisions of the Land Use By-law, that a proposed development is permitted and identifies the development control standards which apply to the proposed development.” That’s quite the definition, but what does it really mean, when do you need one, and why does it matter?



First, let’s answer the “when”. A Development Permit is needed for some interior and exterior alterations or renovations, additions, tenant improvements, selective or partial demolitions, changes to, or the addition of, business activities*. This would include adding or removing structural walls, adding signs, building decks, starting a home business or changing the business in a commercial space, installing heat pumps or solar panels. This is not the entire list, but it makes clear that the Development Permit covers a lot of ground.

Next is the “why”. This all goes back to the Municipal Planning Strategy (MPS) and Land Use By-Law (LUB). The LUB is the governing set of rules, developed by the residents of Annapolis Royal, that guides all development in the Town. This helps maintain the character of the Town

while supporting economic growth in a sustainable and controlled manner. It prevents the construction of a light industrial business in a residential area, protects environmentally sensitive lands, and helps ensure that the Town can grow and change while still remaining livable and essentially “Annapolis Royal”. By applying for and receiving a Development Permit, you can be certain that your proposed change is in line with this vision and the rules.

Hopefully, this makes clearer the intent of the Development Permit and when one is needed. However, we do not expect this to answer all your questions. For that we have our Community Development Coordinator, Ken. If you have any questions regarding whether a Development Permit is needed, or about the process, do not hesitate to get in touch. 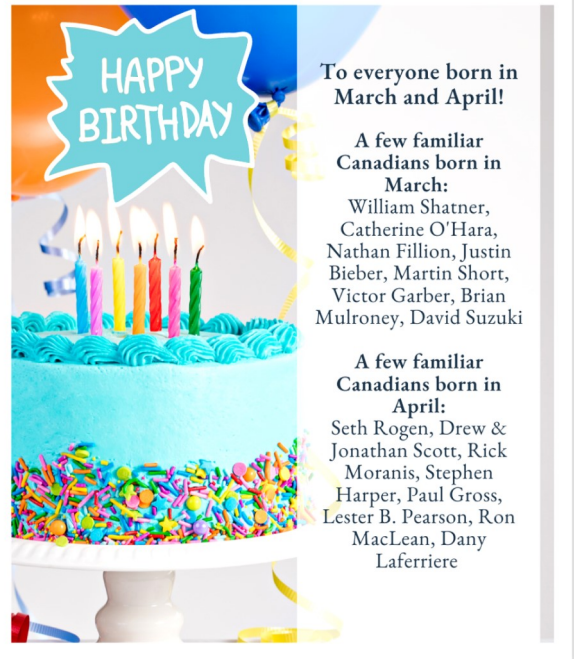

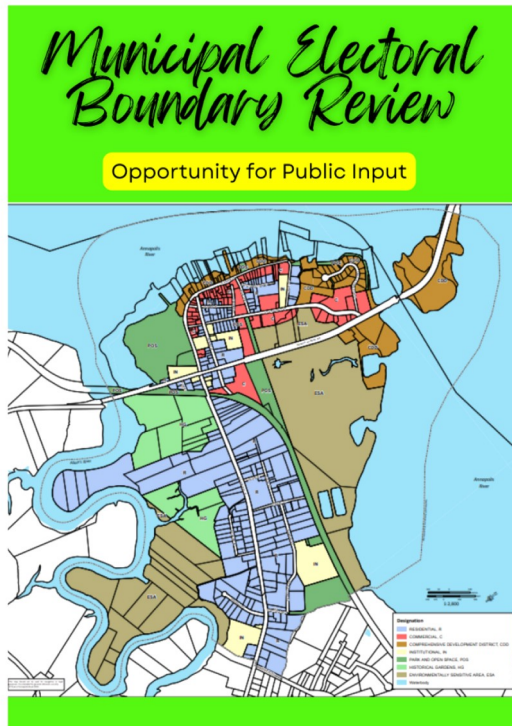
