- MAMP kickoff meeting
 - It was noted that the Town's application for \$50,000 in Municipal Asset Management Program funding was successful
 - Mayor Boyer attended the kickoff meeting and noted that it was an interesting
 meeting with lots of talking about infrastructure and climate change. Mayor
 Boyer shared the work of this committee and the FRA, as well as that the Town
 received a \$25,000 grant for an engineering study.
 - It was suggested the Town proceed to tender and that the AIMS group will
 review the information gathered to investigate additional options for future
 grants. It was also noted that AIMS may apply for the tender. AIMS noted that
 it is pleased to know that this committee has regional collaboration and said
 that the Town and Committee are at the forefront of this type of work in the
 Province.

ii. Green Fund

- NSFM sustainable communities challenge fund was announced January 17,

i. Sea Level Rise

- Mayor Boyer has proofread and made suggested edits, this version will be forwarded to Chair Bottomley for final edits and formatting
- The FRA executive summary will be forwarded to the Council as an update to Council

ii. Draft Climate Change Plan Update

- Miss Winsor noted that she continues to dissect the previous Climate Change
 Plan and reconfigure the flow, creating subsections and formatting for ease of
 reading. She will be meeting with CAO Millett-Campbell to review the format. It
 was noted that the plan from 2012 is no longer viable for the Town; it can be
 updated in its current PCP format, but rather format and update so that it
 doesn't conform to PCP format, thus allowing greater freedom to create the
 most appropriate plan for the Town.
- It was further noted that the Town is approved at milestone 3 by PCP. To get milestone 4 approval there would need to be some analysis and assessments performed and benchmarks need would need to be re-established. Miss Winsor noted that milestones 4 and 5 evaluate and outline how the Town would be applying the Plan. It would also need to go to FCM for approval, as well as Council. It was also noted that CARP has done a significant amount of analysis and assessment on Town buildings which could be applied towards milestone 4, but there are other pieces that would need to be done such as community engagement

iii. Public Education Session on Energy Upgrades

- In Mr. Cliche's absence, Miss Winsor noted that CARP did get approval for a summer intern who will be working with both her and Mr. Cliche
- iv. Renewable Energy Device Installation By-law

 It was noted that this by-law was brought forward to review, approve, and recommend to Council. The proposed changes were reviewed, and appendix A completed (it had been blank previously). Some formatting suggestions were made, Miss Winsor noted these suggestions and will make the updates and revisions
