MAYOR'S MESSAGE



News and Updates

Hurricane Lee

Public Works have many checklists. However, when it comes to weather events, they have one for cold weather and another for warm weather events. A week before the storm, they got to work on their warm weather checklist.



All Town trucks, generators, gas tanks and power tools were gassed up; they started up the Town's generators and ran all the chainsaws and other power tools. They could be seen around town clearing all of the catch basins, shovelling out the leaves and other debris so that any water would flow as quickly as possible. All light objects such as blue barrels and extra garbage cans, chairs and tables were picked up and put away. Generators were pre-positioned at the Police Department and at the wharf lift station where a mobile generator was locked into place. A mobile generator was also positioned at the sewage treatment plant so that in the event of a power outage, Public Works staff could go and start the generator to ensure continued operation of the UV lights.

Wet weather gear, safety hats, first aid kits and safety equipment were readied for use. Response/call lists were updated and at 4:20 pm on Friday, September 15, a situation report was sent to our Regional Emergency Measures Coordinator stating that the Town was ready for the impending storm and prepared for 50 to 90 ml of rain and 90 km/h winds.

On behalf of the community, I would like to thank our Interim Head of Public Works Ken Knox and the Public Works Crew for their storm preparations and their care in ensuring that the Town would continue to comply with all safety requirements for the protection of staff and Town systems and infrastructure.

Atlantic Infrastructure Management Network Conference

CAO Sandi Millett-Campbell and I travelled to Moncton on Monday, September 18 to make two presentations at this conference. We were asked to talk about strategic planning for small communities and accessing funding for municipal projects, as well as accessing alternate sources of funding from organizations such as insurance companies and not for profit organizations. We provided the group with examples of past projects such as the Ducks Unlimited Town Marsh Project and the current sewage treatment plant projects and discussed the importance of planning over the long term and the impact that previous councils have had on influencing our collective future.

CHIEFS CORNER

I thought it would be great to share over the next two Chiefs corner segments the process in a criminal case. The information was obtained straight from the Public Prosecution Service in Nova Scotia.

The Criminal Case Explained Part 3

Trial

The trial determines whether the evidence proves beyond a reasonable doubt the accused is guilty of any or all of the charges. A basic principle of Canada's justice system is that the accused is innocent until proven guilty.

The Crown Attorney presents the evidence against the accused. This is done by calling witnesses and introducing materials as evidence to support the charges. A statement given to police by a witness is not considered evidence. The witness must testify in court.

Each witness called by the Crown Attorney is asked questions. This is called direct examination. The defence lawyer is then given the chance to dispute the Crown's evidence and bring out evidence favoring the accused. This is done by questioning the Crown's witness and is called cross-examination.

After cross-examination, the Crown is given a chance to question the witness again. This is done if the witness's evidence needs to be made clearer. This is called redirect examination. During redirect examination, the Crown may only question the witness on matters brought up by the defence during their cross-examination.

Once the Crown has presented all its evidence, the defence is given an opportunity to present its case. The defence may decide not to present any evidence at all. If the defence chooses to present evidence, they do so by calling witnesses just as the Crown did. The Crown is able to cross-examine the defence witnesses. And, the defence may redirect after the Crown's cross-examination.

After all the evidence is presented, both Crown and defence make their closing arguments. In their closing arguments, each side sums up their case.

The verdict

Once the judge or jury has had the chance to consider all the evidence, three verdicts are possible: guilty, not guilty, or in the case of a jury trial, a "hung jury". A hung jury means the jury was not able to reach a unanimous decision. And, jury members do not believe one can be reached. In this case, the judge will order a new trial with a new jury. If the accused is found by the judge or jury to be not guilty, the accused is free to go and cannot be tried again on the same charge, unless the Crown successfully appeals. If the accused is found guilty, the judge may pronounce the sentence immediately or may set a later date for sentencing.

Sentencing

The sentence is decided by the judge. The Crown Attorney and defence lawyer may make sentencing recommendations. The judge considers these recommendations but he or she makes the final decision on sentence.

The Criminal Case Explained Continued from Page 4

Appealing the verdict or sentence.

An appeal is a request to a higher court to change a verdict, a sentence or some other special order made by a lower court. The Crown may appeal a verdict of not guilty. The Crown may also appeal a sentence it believes does not fit the crime. The defence may appeal a verdict of guilty. The defence may also appeal a sentence it believes is too harsh.

Appeals cannot be made just because the Crown doesn't like the decision. Appeals must be based on errors made by a trial judge on a point of law.

In summary conviction cases, the appeal can be made to either a judge of the Supreme Court of Nova Scotia or the Nova Scotia Court of Appeal. But most summary conviction cases are taken to the Supreme Court of Nova Scotia.

Appeals in indictable cases must be taken to the Nova Scotia Court of Appeal. When appealing a verdict of not guilty, the Crown must show that the trial court made an error in interpreting or applying the law. And, the Court of Appeal must be satisfied the verdict might have been different if the error had not been made.

When appealing a sentence, the Crown must persuade the Court of Appeal that either the judge didn't correctly apply the sentencing principle or, that the sentence is clearly unreasonable. The Court will not change a sentence simply because it may disagree with the sentence.

Jeff Hafting 2023 Provincial Volunteer Representative



Jeff Hafting is a founder and current President of the Annapolis Innovation Lab Society, an accessible makerspace that houses desktop computers, audio recording gear, 3D printers, Cricut Makers, fabric arts equipment and robotic sets for free use by members. The Lab also lends electronic equipment (audio recording, cameras, drones, etc) to the community as easily as signing out a library book. He coaches Soccer and Track & Field and recently led the Annapolis West Education Center's (AWEC) Senior Boys Soccer Team to a Provincial Championship, the first since 1990. He also coaches the Royal Robots, a competitive robotics group that has won 11 consecutive Maritime Championships since 2014 and has won Gold and Silver at international World Championship events. His robotics teams have helped to raise funds for accessibility improvements at the Annapolis Community Pool, where he volunteers, maintaining equipment and operations. He is a founding member and Scientific Advisor to the Annapolis Space Agency, a group of high school students who launch sensor packages and cameras into the stratosphere on high altitude balloons from the field at AWEC and then retrieve them upon landing.






