ii. Climate Conference – November 2, 2024

Climate Lead Walker would like to thank everyone for their feedback regarding this event. They added that Next Ride plan to bring some EVs for residents to test-drive, and Efficiency Nova Scotia will also be attending to discuss rebates/energy efficiency. Recording Secretary Dunning will add the poster to Facebook, and it was agreed to add this and other items to the Town's Newsletter. Stephen Hawboldt asked what the set-up would be for the rooms and Climate Lead Walker responded that there would be approximately 10-15 tables, and they plan to be in Annapolis Royal the day before the conference. Stephen Hawboldt added that it might be an idea to hold it in one room only. Climate Lead Walker advised that there would be coffee/snacks available. Stephen Hawboldt suggested having communications between this committee to ensure everything was arranged, and Climate Lead Walker will share an Excel document to allow each Committee member to include their contact information. Mayor Boyer will contact Active Living Coordinator (ALC) Scanlan to ask if the room is available the day before and if there are tables available. Councillor Hafting shared ALC Scanlan's contact information with Climate Lead Walker. Mike Bernard also suggested having a meeting the day before the conference and it was agreed to have it on Friday, November 1, 2024, at 11:00 am at Town Hall. Mayor Boyer wanted to thank Climate Lead Walker for their assistance in applying for grants for marsh restoration. They added that the marsh restoration can be done independently from the seawall. Recommendation to include this in the newsletter.

iii. Downtown Sidewalk Clean Up - Update

Mike Bernard wanted to bring to everyone's attention the cigarette butt receptacle outside of Fort Anne, as it doesn't stand out, and this could be one of the reasons it isn't being used. Councillor Hafting advised that at the last EAC meeting, Levi Cliche was going to contact a group of volunteers who have cleaned the sidewalks in the past to see if they were available. It was agreed to set up a date for this, and include it in the newsletter, and ask residents to participate. Councillor Hafting added that when this happens, the volunteers need to spread out to cover more area. Mayor Boyer advised that all volunteers need to wear a traffic vest. Councillor Hafting asked if Public Works could clean the gutters, as this hasn't been done this year and Mayor Boyer will follow up with them. Mayor Boyer has a poster that can be edited to suit

and will share. Councillor Hafting suggested a cleanup could happen twice a year going forward. It was agreed to have the clean up on November 9, 2024, from 10:00 am to 12:00 pm, and have a signup sheet at the Climate Fall Conference.
